I. <u>Eligibility Criteria for Application</u>

- 1. Only Indian Nationals are eligible to apply.
- 2. The candidate should have passed their Diploma in above mentioned branches recognized by AICTE or GOI on or after 01/10/2021.
- 3. Age limit: Maximum age should not be more than 25 years as on 01/10/2024. Upper age relaxation of 5 years for SC/ST and 3 years for OBC & 10 years for PWD candidate.

II. General Instructions:

1. Candidates who fulfill all the above criteria are eligible to apply.

- 2. The duration of Apprenticeship training is one year.
- 3. Stipend shall be paid as per Apprentices Act, 1961 (as Amended).
- 4. Candidates can apply for the above vacancies through Portal <u>nats.education.gov.in</u> on or before 04/11/2024.
- 5. The candidates should not have completed or undergoing apprenticeship training in other organization Candidates who have already completed their apprenticeship or terminated their apprenticeship mid-way or pursuing their apprenticeship with other organizations are not eligible.
- 6. Reservation for SC/ST/PWD/ OBC/EWS etc. candidates will be as per the Government guideline.
- 7. During the period of apprenticeship, candidates will be governed by the 'Apprentices Act, 1961 as well as the policies/rules of the organization.
- 8. Canteen facilities will be available on chargeable basis.
- 9. Interested candidates are required to register on BOAT portal <u>nats.education.gov.in</u> the application received after last date (i. e, 04/11/2024) will not be considered.
- 10. The shortlisted candidates will be informed for Written test through their registered E-mail ID.
- 11. The number of vacancies to be engaged is indicative and may be changed by Management without any further notification and without assigning any reason thereof.
- 12. Bharat Electronics Limited Ghaziabad has no obligation to give regular employment to Apprentices.
